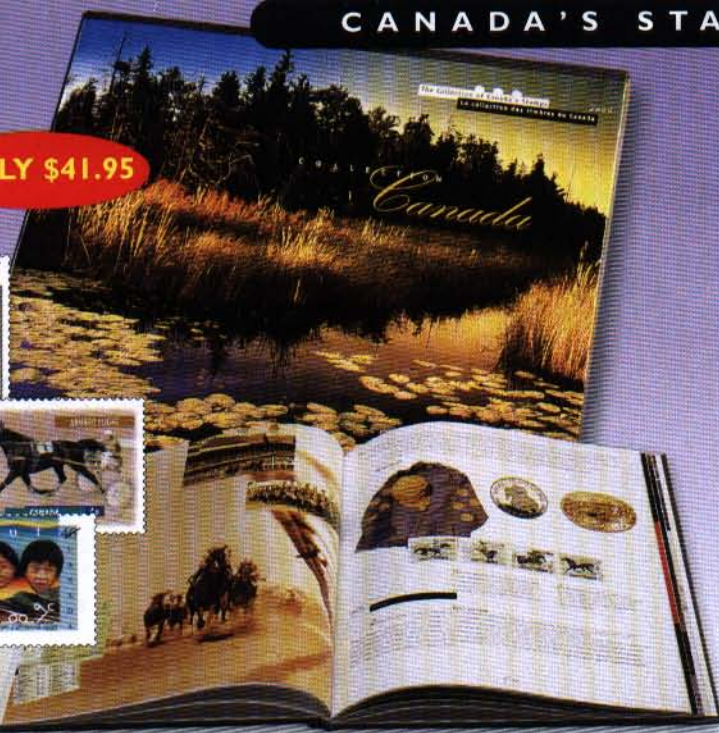

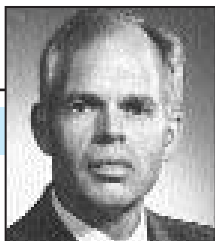
The News Year's Greeting Card (circa 1870s) reproduced on the front cover is a hand-painted celluloid piece - a popular method used about 130 years ago.

I write these notes on the first day of December, reminded as I do that time really does fly and that I had better get the Christmas card list out. I still enjoy very much the sending and receiving of cards. I was in a long range planning, but frugal, mood last Boxing Day when I loaded up with half price cards. Now, if Canada Post could just be persuaded to sell half price postage! It costs 92 cents postage to say hello to British collector pal, David Sessions. I wonder if David has a telephone and whether Canada Post really wants to be in this Christmas card business? A few years ago, the Chair would get into the spirit of things and reduce the price of postage by a nickel at holiday time, but no more. And 92 cents? Well, there still is a bit of magic in discovering a treasure from someone other than Mr. Visa in a mailbox some thousand miles away... This grinch thinks that it just may still be a bargain after all. And to my Christmas card list friends, I add several thousand Holiday greetings on behalf of your Royal Directors and Officers. Now, that's getting one's money's worth!

The Royal has a number of excellent member services and benefits and our hope is to continue to build the value of your Society membership. Most members know that very good collector insurance is offered through the firm of Hugh Wood. Many members Chapters participate in our liability insurance program which offers full coverage at very modest group rates. I am reminded of this particular program because policy renewals are currently being sent to our Chapter subscribers. A note to those who have enquired: your policy remains in effect during that period between expiry and renewal billing.

Edmonton Club "Bulletin" editor, Alan Meech, reminds of the importance of such Club liability insurance and while we might lament the times and the need, it is a good idea, to give the matter some thought. South of the 49th, our Boeing Employees Stamp Club friends must sign a release and indemnity agreement in order to participate in club activities. How about "In consideration of the right to participate in Stamp Club activities, I hereby release the club and its instructors and members and the Boeing Company from any and all liability claims and causes of actions arising out of or in any way connected with my participation in stamp club activities."

Add 12 more lines - many in CAPITAL letters and an introduction that recognizes that stamp club activities "may have certain risks." Dear Editor,

With regards to the Judging Sheet Report appearing in Vol. 50 No. 5, the September/October 1999 issue of the *Canadian Philatelist*. I have read and re-read this article several times trying with great difficulty to make sense of what was presumably written by Ken McGee.

Maybe there is need for change in local exhibiting but to say that rarity, scarcity and philatelic importance are not part of the judging criteria simply doesn't make sense; (under presentations) especially in view of the two previous paragraphs stating the degree of difficulty normally expected in assembling the material shown and an assessment of the quality of the material shown relative to the condition in which such material is readily available. Does that still mean that rarity, scarcity and philatelic importance doesn't count? Doesn't rarity and scarcity mean the same? Let's go back a little more to selection; The presence of unusual and interesting items should be given consideration. Just too many ambiguous statements for my liking.

The focus of the suggested local judging criteria seems to be on the title, outline and index or table of contents. The exhibit should have a clear beginning, again title page, a central theme and a logical ending without saying the end. How can you possibly not say the end. Regardless of whether you tie the conclusion in with the title page or not, a conclusion is a conclusion.

After reading this article I couldn't help but think back to the London Philatelic Society exhibition held in the spring of 1999. There were several exhibits that could easily have been awarded a vermeil at most national shows. Yet, not a single gold was won by any of the exhibitors. Mr. Ken McGee, an influential advocate of this illustrated system was one of the three judges. So much for local judging.

Changes are needed in the various levels of exhibiting but not at the expense of compromise. The material shown should be of good quality and good condition regardless of the level of exhibiting, and it (the material) must tell a progressing story from beginning to end as per the introduction.

This is where a degree of rarity or difficult to find material enters the picture. It is the responsibility of the exhibitor to put his best foot forward at all times.

On the other hand it is also the responsibility of the stamp club to hold seminars on exhibiting if it is their intention to sponsor such shows. The jury on the other hand should con-

sider the level they are judging. As for the exhibitor, the level of medal earned locally cannot be expected regionally or at the national level. The requirements are stricter.

There's a lot of merit in the format suggested for judging. The outstanding point is the presentation of the judges points awards in writing to the exhibitor. Judges should endeavor to accompany this with a constructive critique. Allow me to give an example using knowledge and research for 25 points; (by the way, I believe this is where philatelic importance comes in). If a judge awards 20 points only with the comment nicely done or no comment at all, I want to know why I didn't receive 25 points. Exhibitors would then have an idea in what areas and to what degree they would need to improve.

Exhibiting should be a pleasant and enjoyable sideline to this great hobby of philately and judges should go to great lengths to encourage exhibitors at the local level by recognizing their efforts.

I would like to comment on the fifth and sixth paragraphs of the editor's note. Philately is a hobby and hobbies cost money. Especially this one. A collector will normally try and improve a collection. If there is a passion for a particular category, the purchase of an item is sometimes supplemented by the selling of other material. There are one page exhibits or one frame (16 page) exhibits that are not all that expensive to create depending on the subject. I agree that the national and international scene is not for everyone if we are to consider the cost of frames, shipping and handling of material and the cost of insurance, etc. However, let's keep the competitive edge alive.

Based on 100 may I suggest the awarding of points in the following manner: Title (title, introduction and index, max. two pages) 10 points; Philatelic Material (relative to subject, condition, degree of difficulty) 50 points; Knowledge and Research (personal study and write-up) 25 points; and Presentation (visual appeal, mounting, layout and continuity) 15 points.

May I also suggest that exhibitors, even here at the local level, submit photocopies of title and index pages a sufficient time in advance to allow judges an opportunity to familiarize themselves with the material they are about to judge.

I sincerely hope this article receives a high degree of response. Seldom do exhibitors agree with judges but then again, part of the enjoyment of exhibiting is challenging these people. We, for the most part believe in your sincerity and what you add to the hobby. Therefore, it's wonderful that you come to the general philatelist asking for input, good, bad or indifferent.

Happy New Year to all the readers.

As we move towards the 21st century, it is time to look ahead at new opportunities for this publication. (The editor is one of those people who believes that the 21st century begins on January 1, 2001). To start that process we need to realistically look at where we are.

The format for this journal was changed early in 1999 by others involved in the production. When this editor came on the scene, a new approach was attempted. The goal was to make this publication more meaningful and entertaining to the modern day collector.

Within the short few months I have been the editor, there have been two new editors at Trajan Publishing and three different people assigned for special duties provided by Andrew Parr & Associates at the Toronto office. Not only has there been steep learning curves for six different people performing different roles, but the ground has been shifting under everyone's feet. The shortage of articles for each edition and tight production schedules add to the mix. Some functions took longer because of missed communications, delaying the publication date even longer. Somehow, we have managed to scramble around and put together the best we could under the circumstances. Steps have been taken to solve those problems and attain a quicker turn-around time. Other steps are being taken to arrange for the return of illustrations supplied with articles in a timely fashion.

Stamp collectors are trained to look for errors because sometimes the errors make the stamp more valuable and a more desirable collectors item. So it is no wonder that we have received letters from sharp eyed readers pointing out typographical errors and a few mistakes. These errors provided an unintended and accidental way to make our publication entertaining to those who like to find mistakes. The errors and omissions were caused by the combination of factors listed above. The mistakes were not intentional nor meant to offend anyone – just one of those things that happen. We

then have to remember The Lord's Prayer, to forgive and forget. Who knows? Maybe those editions can become "collectors' items", too. Some significant corrections are included elsewhere in this issue.

To understand how the process works, here is a snapshot picture. As you are reading this magazine, the next issue has already been mostly prepared. Typesetting has begun and preliminary layouts prepared. We are receiving and reviewing articles for the issue which will be in the mail to you four months from this same time. Part of the problem is the time involved in typesetting. If you can provide your article on disk, much time is saved. If not, please get it in early so the typesetting can be done ahead of time.

Other changes are being planned. According to our President, about one-half of our membership live in Quebec. Understandably, many of those readers are more comfortable with the French language than the English language. We need to build a better bridge of understanding between the two languages. It is too important an issue to leave up to politicians and bureaucrats, so philatelists need to solve the problem within their own groups.

Here is our main problem. As much as we would like to translate each article into an alternate language, we just do not have the finances to accomplish that goal. So we need to find a compromise. Instead of requiring that every article be written in the English language, we want to encourage those who feel more comfortable in writing French to send in their articles. We do not have the funds to translate those French articles into English either, but they will be published. Those who cannot read French, will just have to do the best they can to understand what is being written. That seems fair, since many French speaking members have not clearly understood every word that has been written in the English language.

So, all of those who can write in French are encouraged to send in their articles for publication. After all, the official language of the Universal Postal Union was French for many years, it is

only recently that the messages have been also translated into English.

It is hoped that we can obtain a balance over the year between the two languages. As such, our publication will become somewhat unique. It will open up the possibility of attracting new French speaking members from around the world – French Polynesian as an example. The percentage content in each issue will probably vary between which articles are most interesting. Some issues may contain more articles written in the French language than in English, and other issues may be vice versa.

Writer's guidelines have recently been prepared to assist those who wish to contribute articles. These guidelines have also been translated into the French language. An associate editor, Grégoire Teyssier, has been appointed to review all submissions written in the French language because my French language skills are not up to that task. In that way, we hope to maintain a high degree of philatelic credibility and accommodate members speaking both languages.

In this issue, along with the usual columns, you will find an explanation of aerophilately. Another collector describes how he put together a Canadian stamp collection. His plan, with modifications, can be used by any collector for almost any country. Joseph Monteiro explains how hologram stamps are produced. Part II of the Submarine article is continued in this issue. You will read an interesting story about Myanmar, and how one collector channeled his passion into a lifelong pursuit. The results of his research and organizational abilities will benefit other collectors for many years to come.

Ken Magee has revised the draft judging forms published several issues ago, based on responses received from other interested parties. A list of qualified judges is enclosed for those who are planning to hold or enter exhibits. Also enclosed as centrefold inserts are the registration and exhibit entry forms for the Royal convention to be held in Winnipeg, April 28th to 30th.

Aerophilately: What is it – How to collect it

Aerophilately, as a discipline within the hobby of philately, has undergone many changes over the past 80 years. This article will hopefully clarify what is meant by the term to provide a guideline for those who are attracted to it by the romance of the history of flight itself, in addition to the basic pleasure of collecting.

According to the FIP (Federation Internationale de Philatelie), the ruling body for international philatelic exhibiting, aerophilately represents a study of the development of airmail services and a collection of documents pertaining to such developments. This may sound rather simple but, within the definition, there exists a scope so broad that it parallels almost the whole spectrum of philately. In expanding this definition, I will relate it to the Canadian scene which, through familiarity, can make the development clearer.

Historically, aerophilately as a separate, respected, discipline has had a very rough time within the upper echelons of philatelic ruling bodies. In earlier days, the study of the stamp itself was paramount, and even postal history was frowned upon. The earliest attempts at collecting airmail consisted largely of covers carried by favour by pilots making historic flights. These were considered outside the realm of respectability as they were contrived items that did not go through the postal process. One of the most prolific creators of airmail covers in the 1920s and 1930s was an American dealer, A.C. Roessler. He developed a chain of collaborators around the world consisting of other dealers, major collectors, etc. who tipped him off when new flights were to be attempted and who helped him create the covers. He would offer the pilot \$1,000 to carry 100 covers for him on an exclusive basis. This, frequently, was important to the pilot who needed all the help financially that he or she could get.

This technique was frowned upon then, and his name is still today looked at with suspicion. However, without people like Roessler, we would today not have many of the covers from the great historic flights of the early development period.

As the years progressed, many new aspects of airmail were developed, and, as the specialty grew, it eventually had to spin off one of its later developments which had grown so big that it needed a separate realm of its own. This is now astrophilately – the study of mail in space – which is no longer an integral part of aerophilately.



At the start of the Graf Zeppelin's career in 1928 and through 1929, it made a number of publicity flights to get support from backers. One of these was the Orient Flight which left Friedrichshafen March 24, 1929 for a flight over Palestine and return. There was no landing and mail for the area was dropped in three mail bags. The cover shown was not dropped, but was carried back to Germany and continued by surface mail to Oseenden, ON, arriving April 16 via Warton. The cover is also interesting because of its nice six colour franking, which, while appearing philatelic, is the correct postage rate of 2Mk.

A collection or exhibit of airmail may be developed in a myriad of ways. The most common way is to study the development within a single country. This, in itself, can be broken down into three periods: a pioneer period, a development period, and a modern period. In the case of Canada, I would define the pioneer period as 1914 to 1924, the development period as 1924 to 1939, and the modern period as

1940 to present. These periods will vary from country to country. i.e. the pioneer period in countries such as Germany, France, etc. was earlier than Canada. A comprehensive collection of Canada would include examples from all the categories in the sub-sections that follow.

Within a geographical area one can make a collection of airmail routes. In the case of Canada, the first airmail contracts were assigned in the winter of 1927-1928, and from then on new routes were opened with increasing frequency, until by the late 1930s, the whole country was covered. The covers related to these route developments are labeled in the *Canadian Airmail Catalogue* as "Government flights and stages." Some people collect these as first flights, as pilot signed flights, or as commercially used flights with scarcer usages or destinations.

Over the years, airmail rates have changed like any other postage rate. The first regular airmail rate of five cents was introduced in 1928 with the first five cents airmail stamp issued in September 1928. (There was a one time airmail rate of 34 cents to Newfoundland in 1921 but this was for one flight only). Collections have been made tracing the changes in airmail rates over certain periods of time and usages to various destinations. In this sense, aerophilately is very similar to postal history, and the type of collecting is sometimes referred to as aerpostal history. This is the aspect most respected by non-airmail judges, who sometimes still turn up their noses at first flight covers. In fact there have been recent attempts within the FIP to have aerophilately and postal history combined as one discipline.

One can collect the route development of just one airline or of just one route. In the case of Canada, there are collections of Air Canada and Canadian Pacific Airlines, but the most common Canadian

airline collections are those of some of the bush airlines that operated between 1926 and 1931. Within the larger world frame, the most popular airline collections have been those of Pan American Airways and of Imperial Airways. The most popular route collecting is probably the "Mermoz" line, which is the study of the French development of the route from France to South America.

There are collections of airmail by service i.e. army, navy, etc. This is not very common for Canada but one finds these for Germany, Italy, etc. Another less common division is by aircraft manufacturer. There are several major exhibits of Blériot (early French aircraft) and many of the "DOX" – a large Dornier (Germany) aircraft that made a transatlantic flight in 1930-32.

Aerophilately comprises development of airmail by means other than traditional aircraft. Mail has been sent by pigeon. There are some great collections of pigeon mail. There are collections of airmail by glider and by rockets. The latter are more usually now found in astrophilately. However, by far the most popular, and one of the major fields in aerophilately is mail flown by dirigible and by catapult. While several countries have used these services, they are primarily identified with Germany. From 1929 to 1936, the steamships Europa and Bremen were equipped with catapults from which they could launch an aircraft when within a day of arriving at their destination. This aircraft carried mail which would save at least one day in delivery of the normal method of waiting for the ship to dock. In the same period, from 1928 to 1937, the most famous of the dirigibles – the Graf Zeppelin and the Hindenburg, carried mail in a scheduled service from Germany, over both the North and South Atlantic, to the USA and to Brazil. Various countries contracted with the German post office to have mail carried from their country on the dirigibles. Canada was not a contracting country but there is mail on both the Graf and the Hindenburg and on the catapult service both to and from Canada – all via New York and Lakehurst, NJ.

There is one area of aerophilately which is not present in most countries, but which is most important in Canadian

airmail. This is the study of semi-official airmail. These are stamps issued by private airlines covering the fee charged for carriage of mail on their flight routes. It is official because it was authorized by the government. It is "semi" official because it was not a post office issue. From 1924 to 1939 13 private airline companies were authorized to issue

ignored is for some of the Brazilian semi-official stamps, and I suspect that "politics" entered here.

There are a few other countries where semi-official airmail stamps have been used but by far the most popular and most important are the "consular" stamps of the Colombian airline SCADTA – the predecessor of the current airline AVIANCA. SCADTA operated routes in the 1920s from Barranquilla to the Colombian interior. Their consulates abroad and selected selling agencies stocked overprinted stamps with the initials of the originating country. Persons wishing to send mail by air to interior Colombia cities would buy these stamps and enclose them in a separate envelope addressed to Barranquilla from where SCADTA, for the fee paid, would carry the mail. SCADTA stamps from Canada with a "CA" overprint are very rare. There is also mail from Canada with a later issue of SCADTA stamps which is also quite rare but not as scarce as the consular overprints.

There are many other elements in airmail which can provide lots of enjoyment to the collector. I probably will forget some but, acceptable within aerophilately are, postal stationery including aerogrammes and airmail postcards, airmail etiquettes (those little stickers saying VIA AIRMAIL) and vignettes used on cover, cancellations, cachets, transit, route, and other explanatory markings, and even covers or cards intended to be flown on an historical flight but which did not get flown.

Lastly, but not the least important, are interrupted or crash covers. A crash cover is one where the aircraft crashed and the mail was recovered and forwarded by surface. An interrupted mail is one where the flight was interrupted by accident or some other cause, but which later resumed and was eventually delivered. For those who would like to learn more about airmail collecting, I would recommend membership in the Canadian Airmail Society.

stamps. These bush airlines were largely responsible for opening up the mining and forestry industries in Northern and Western Ontario, the Prairie Provinces and BC, and particularly, the Yukon and Northwest Territories. Some issued single stamps. Some had several issues, and one other airline even issued a stamp with no proven record of government approval. The stamps and covers of these airlines make up a major element in Canadian airmail collecting and they are popular all over the world. One can actually collect any one of these stamp issues as though it were a "traditional" collection, i.e. collect the essays, proofs, mint stamp issues, colours, papers, perforations, errors and varieties, and postal usages. While this is a correct aero collection, in competitive exhibiting, the judges prefer to see the stamps on pages only in combination with usage on cover. The only examples I have ever seen in international exhibition where this criteria seems to be

Submarine Arctic Operations

Editor's Note: The following article was scheduled for printing in Opusculum II. Since Opusculum II will not be printed, this article appears here with the author and the Philatelic Research Foundation's approval.

Part II

Sublcex 1969, USS Skate, Whale (SSN-638), Pargo (SSN-650)

In March 1969, *Skate* departed New London for her fourth venture into Arctic waters, this time to conduct submerged operations under the ice in company with *Pargo* and *Whale*. *Skate* visited Faslane, Scotland after the operation and returned to New London on May 13. The ship received a Meritorious Unit Commendation for this operation.

A special cachet for *Skate* was not issued for this operation. However, the Nuclear Ships Chapter of Universal Ship Cancellation Society had sent a number of 10th anniversary covers to *Skate* for servicing on March 17th. Carried on board during the Sublcex but forgotten about upon return, the covers were finally posted at the Submarine Base nearly a month after the ship's return, with a note of explanation from the ship's Public Affairs Officer.

USS *Whale* (SSN-638) and *Pargo* (SSN-650), commissioned in 1968, were submarines of the *Sturgeon* (SSN-637) class, ships of which were designed with an ice suit. The Icex was designed to test the under-ice capability of this class of submarines and research new concepts of submarine under-ice tactics.

Whale departed Charleston, South Carolina, March 18, 1969 for the combined operation. Upon completion, she set course for the North Pole, arriving April 6, 60 years to the day after its dis-

covery by polar explorer Robert E. Peary. During the operation, *Whale* conducted numerous surfacings through the ice pack gathering valuable scientific data. For her part in Sublcex 1-69, the ship was awarded a Navy Unit Commendation.

The cachet employed by *Whale*, designed by the Commanding Officer, Commander William. M. Wolfe, Jr., is a modification of the regular ship's cachet. A post office was authorized for this mission and a Locy system type 2n cancel was used for approximately 1,200 covers, all of which were serviced while the ship was actually surfaced at the Pole. Both the cachet hand stamp and postal cancel were destroyed after the trip.

Underway from New London March 24th, *Pargo* steamed 5,830 miles under the ice in 24 days and made 21 ascents through the ice. A polar visit had not been scheduled, but authorization was received during the operation and *Pargo* surfaced at the North Pole April 25th. *Pargo* serviced approximately 400 covers at the North Pole.

Crew members designed a cachet commemorating discovery of the North Pole 60 years earlier. The cachet was applied by stencil, accounting for the poor centering of some covers. A fancy postmark was manufactured on board using the horse-shoe design of the ship's cachet as its basis.

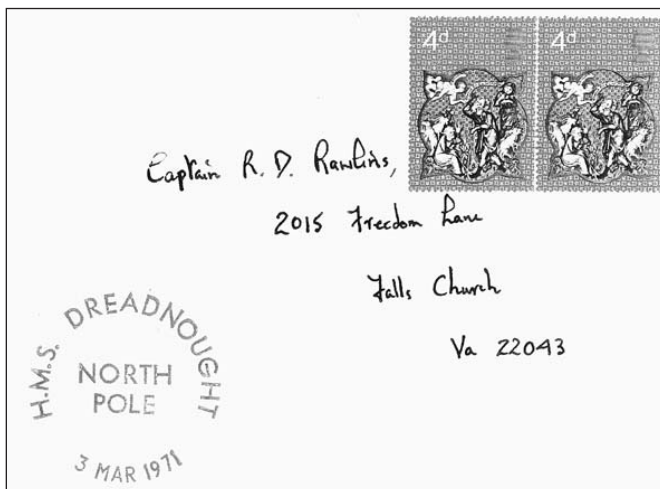


Figure 19. USS *Pargo* issued a cover with mimeographed cachet with fancy cancel produced on board for a 1969 polar exercise. However, covers had been sent only to friends, families and collectors. After the ship returned to port, Admiral Rickover directed that a second mailing be made to navy and government officials. A cover with printed cachet was prepared for this purpose. Because of its limited mailing, this is one of several key covers for polar submarine collection.

Following *Pargo*'s return to New London, a monarch sized cover with printed cachet was prepared and sent to navy and government officials at the specific request of Admiral Rickover (figure 19). The printed cachet is approximately half the size of the stencil cachet, but the postmark is the same on both covers. Approximately 100 covers of this variety were mailed.

USS Queenfish (SSN-651) Polar Expedition, Summer 1970

Queenfish, a *Sturgeon* Class submarine, departed Pearl Harbor July 6, 1970 for Puget Sound for weapons and sound trials. She departed Seattle July 22nd and transited the Bering Strait to conduct extensive explorations of the Arctic Basin. Following the historic track laid by USS *Nautilus* in 1958, *Queenfish* gathered extensive ice profile, bathymetric and oceanographic data on the Arctic basin. Naval scientists were particularly intrigued by the fact that this mission was conducted at the same time of the year, along the same track as the first under ice crossing by *Nautilus*. They speculated that a comparison of ice profile measurements should lead to estimates of changes in the total amount of ice in the Arctic Ocean during the decade of the 1960s. If the ice was thicker in 1970 than in 1958, there had to be a net cooling of the ice. The converse would be true if the ice was thinner. Data gathered by the ship should answer those questions and others of equal interest to science. Aided by sophisticated equipment, *Queenfish* navigated unerringly under the ice and surfaced within 500 yards of the geographic North Pole on August 5th, 12 years to the day after *Nautilus* sent her famous message "Nautilus Ninety North."

A special cachet and cancel were designed for the operation by crew member Seaman Casparzak. The cachet was drawn on a mimeograph stencil and transferred to individual envelopes. After one stencil mat wore out, a second was made and then a third. The designs are similar, but not identical differing in the fineness of lettering and the direction of lean of the North Pole.

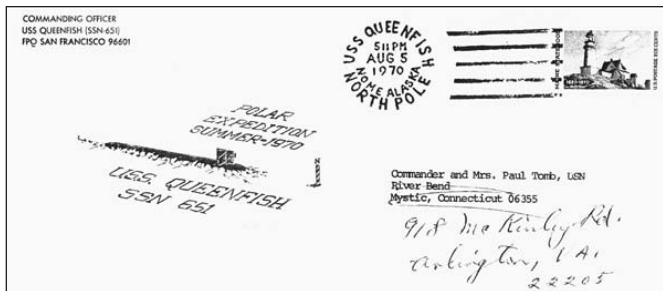


Figure 20. For her 1970 Under Ice Operation, USS *Queenfish* prepared covers with a mimeographed cachet and hand stamped postmark, both produced on board. Variants of both the cachet and cancel exist with six combinations in all.

The cancel device was a wood block, also designed by Casparzak. Actually, two blocks were carved, one before getting underway and the second during the voyage. Again, there are distinguishing marks in each, with the easiest to see is the size of “K” in Alaska and the space between the “EN” of *Queenfish*.

Queenfish serviced an estimated 2,000 covers (figure 20) while at the North Pole. The three stencils and two wood blocks provide six combinations of cachet and postmark.

Sublcecx 2-70, USS *Hammerhead* (SSN-663) and USS *Skate*

Commissioned in 1968, *Hammerhead* departed Norfolk October 12, 1970 and joined with USS *Skate* for the second Arctic operation of the year. Only two members of the crew and none of the officers had had prior Arctic experience, a significant fact compared to specialized training given previous *Sturgeon* class submarines before an Arctic operation. During the deployment, the ship accomplished many notable firsts, including being the first submarine to visit the Arctic region in the fall and by spending more time under the ice than any of her predecessors. *Hammerhead* made a record number of surfacings through the ice including a surfacing at the North Pole on November 20th.

Breaking tradition, the ship used two different cachets designed by crew member, Electronics Technician Searfoss to commemorate her polar surfacing, both of which subsequently remained in use. However, an added two line stamping “North Pole/Nov. 70” establish these as Icex 2-70 carried covers. A variant two line stamping is also known with “North Pole”

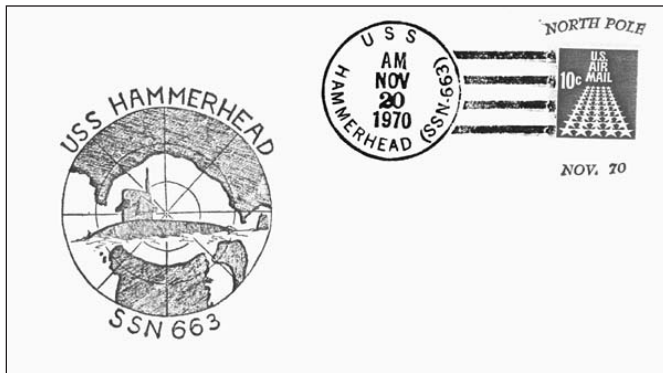


Figure 21. USS *Hammerhead* produced two different cachets for her 1970 polar operation identified with a two line stamping. Some covers have a variant two line stamping with “North Pole” in an arc above the franking and “Nov. 70” below.

curved in an arc stamped above the franking with the straight line “Nov 70” below (figure 21). The postal service authorized a one day post office on board and some 1,200 covers were canceled with a four bar postmark (Locy type 2n) while the ship was surfaced at the Pole.

USS *Skate* issued no covers for her fifth Arctic exercise.

HMS *Dreadnought* North Pole Operation, 1971

HMS *Dreadnought*, the first nuclear powered submarine in the British Navy was commissioned April 17, 1963. She sailed from her operational base at Faslane, Scotland February 20, 1971 bound for the North Pole. The trip was carried out during the most severe part of the Arctic winter with the sun continuously below the horizon. *Dreadnought* spent a total of seven days beneath the ice, steaming over 1,500 miles, breaking through the ice on six occasions including surfacing at the North Pole March 3rd.

The then captain, CDR A.G. Kennedy, RN, described the surfacing at the North Pole: “We have surfaced with the fin only penetrating through one foot of ice. The view is quite breathtaking in the half light of dawn, with great blocks of ice lying against the side of the fin where they have had to be pushed by the surfacing officer of the watch. It is also breathtakingly cold, minus 38 F, which with the wind blowing gives an effective air temperature on personnel of 117 F.”

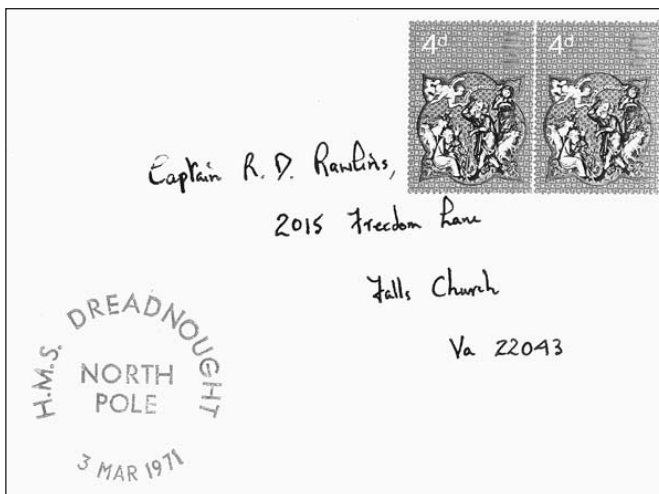


Figure 22. In 1971, HMS *Dreadnought* was the first British submarine to surface at the North Pole. The ship’s executive officer designed a rubber stamp cachet for this memorable event.

A rubber stamp cachet commemorating surfacing at the North Pole (figure 22) was made by hand during the voyage by the Executive Officer, Lt Cmdr Robin Whiteside, RN and used on postcards and letters of those on board.

Sublcecx 1-71, USS *Trepang* (SSN-674) and USS *Skate*

Skate and *Trepang* departed New London on February 16, 1971 for a polar exercise off Iceland with USCG icebreaker *Edisto* during which the ships encountered extreme weather, sea and ice conditions. This operation was *Skate*’s sixth and last penetration of the northern ice pack as more modern submarines took over Arctic research. *Trepang* surfaced 11 times through the ice. Upon completion, both submarines visited Holy Loch, Scotland before returning to New London.

Neither ship prepared a special cover for the exercise. However, the operation has been documented by a *Trepang* cover mailed aboard tender USS *Canopus* on arrival at Holy Loch, Scotland and a *Skate* cover posted at the Groton Submarine Base branch post office upon return.

Sublce 1-73, USS *Hawkbill* (SSN-666) and USS *Seadragon*

USS *Hawkbill* (SSN-666), a *Sturgeon* class submarine, departed her home port of San Diego on March 9, 1973, three days after *Seadragon* sailed from Pearl Harbor, both ships heading for an Arctic rendezvous. *Hawkbill* operated under ice for 21 days and *Seadragon* for 10 days,

with the latter surfacing five times through the ice. The exercise, conducted in the Bering Sea, marked the first time a submarine had successfully operated in these shallow waters under winter ice. Following completion of the operation, *Hawkbill* visited Port Angeles, Washington before returning to San Diego April 13th. *Seadragon* entered San Francisco on April 5th for a four day visit before returning to Pearl Harbor April 16th. This was *Seadragon*'s third and last polar operation.

Hawkbill prepared a special rubber stamp cachet to commemorate her part in the IceX. The cachet, designed by one of the ship's officers and made on the tender in San Diego before departure, was applied during the voyage (figure 23). Covers were postmarked by tender DIXON on April 13th.

Seadragon employed a new cachet to mark this operation (figure 23). The cachet remained in use for several years after but without the boxed "1973 Under Ice Operations." Covers commemorating the exercise were posted upon the ship's return to Pearl Harbor.

Sublce 1-75, USS *Bluefish* (SSN-675)

USS *Bluefish* (SSN-675) was commissioned at New London in January 1971, an auspicious start for a submarine destined to explore the Arctic basin. The ship departed Norfolk in March 1975 on an operation designed to maintain Arctic submarine warfare expertise, evaluate equipment and collect bathymetric data. She surfaced at the North Pole May 4th, the first Atlantic Fleet submarine to do so since 1970. *Bluefish* remained surfaced for 12 hours, during which time the ashes of Lady Suzanne Wilkins, widow of famed Arctic explorer Sir Hubert Wilkins, were scattered to the winds.

Bluefish documented this operation with a cachet designed by the ship and printed on monarch envelopes in advance of the

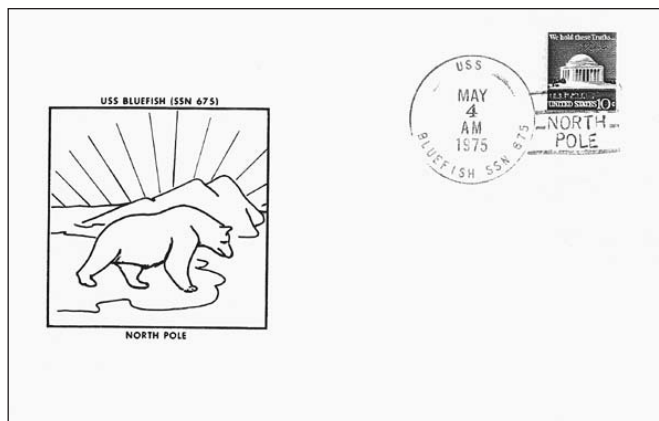


Figure 24. In 1975, USS *Bluefish* printed a polar operation cachet on a monarch envelope. The ship also obtained authorization for a one day post office, the last submarine to receive such authorization.

trip (figure 24). Approximately 2,500 covers with this cachet were serviced. A second, privately produced cachet cover, 208 in number, were canceled by the ship along with fewer than 100 collector covers which received the ship's regular rubber stamp cachet.

Bluefish is the last submarine authorized post office for an Arctic operation. All covers were struck with the fancy cancel illustrated (figure 24).

Sublce 1-76, USS *Gurnard* (SSN-662)

The *Sturgeon* Class USS *Gurnard* (SSN-662), commissioned in December 1968 at Mare Island Naval Shipyard, Vallejo, California, departed San Diego March 8, 1976 for a two month scientific foray in the Arctic. After transiting the Bering, Chukchi and Beaufort Seas and the Arctic Ocean, she surfaced at the North Pole on April 14th, 10th submarine to accomplish this feat. As part of her mission, *Gurnard* provided services to the Arctic Ice Dynamics Joint Experiment (AID-JEX), a national Science Foundation multi-national expedition located on floating ice stations in the Beaufort Sea.

The cachet used by *Gurnard* for the Bicentennial polar expedition was printed in advance with a two line rubber stamp added while surfaced at the North Pole. All covers for this event were #10 size. *Gurnard* returned to San Diego on Saturday, May 8th, but the covers documenting the trip were not posted on her tender, USS *Dixon*, until the following week. The 1825 cacheted voyage covers bear either a May 11 or May 12 date.

HMS *Sovereign*, Under Ice Operation, 1976

HMS *Sovereign*, second of the Swift Shure class and the newest British nuclear powered submarine, departed Plymouth, England October 1, 1976 to conduct an extensive study of the Arctic for the Scott Polar Research Institute. The ship surfaced at the North Pole October 23 (figure 25 not shown), where the officers and crew played a game of soccer, and returned to Plymouth November 5th.

Sovereign prepared a rubber stamp cachet (figure 26) to commemorate the voyage. A second smaller cachet, simply a boxed "North/Pole" is known. Commemorative covers were posted variously from November 9th to the 16th at the ship's home port, Plymouth, England.

SublceX 1-77, USS *Flying Fish* (SSN-673)

With SublceX 73, the Navy had begun alternating Arctic operations between the Atlantic and Pacific Fleets. On March 26, 1977, USS *Flying Fish* (SSN-673), commissioned in 1970, was underway from Norfolk, Virginia. *Flying Fish* surfaced in a lead just five miles from the North Pole on April 30 for eight hours of ceremonies and gathering of scientific data. During the operation, *Flying Fish* visited and worked with scientific personnel on Fletcher's Ice Island, which was temporarily occupied.

Following the operation, *Flying Fish* visited Halifax, NS, where the mail was sent ashore to be processed through the Canadian post. Lacking Canadian franking, the mail could not legally be postmarked. Stamps were killed by various means and covers sent on their way. However, not all mail arrived at its intended destination.

For the operation, the ship prepared approximately 500 #10 size envelopes with a printed cachet which were used mostly for mail to navy and government officials. A rubber dater stamped the date of surfacing at the North Pole, "30 Apr 1977" immediately above the cachet. A rubber stamp cachet (figure 27) was also prepared about twice the size of the printed one and stamped on an estimated 200-400 pieces of collector and crew mail.

SublceX 1-78, USS *Pintado* (SSN-672)

USS *Pintado* (SSN-672) departed San Diego September 12, 1978 for a fall Arctic voyage to collect bathymetric data, further

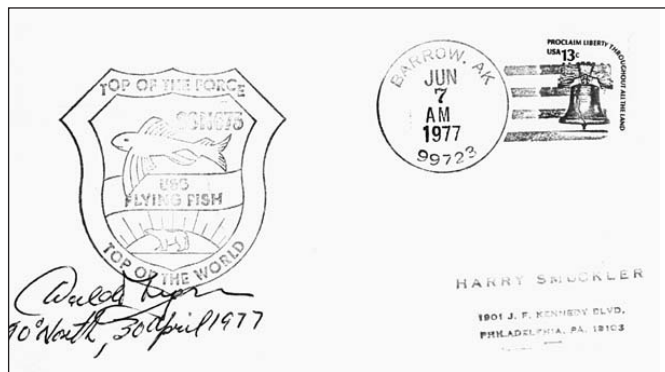


Figure 27. Cover with 1977 *Flying Fish* North Pole rubber stamped cachet and autograph of Dr. Waldo Lyon, senior scientist on board, was left at Fletcher's Ice Island on April 30 and transported to Barrow with station mail where it received a June 7 postmark. Dr. Lyon noted that *Flying Fish* had worked with drifting ice stations at which it was bitter cold and quite different from the previous year's experience with *Gurnard*.

knowledge of the Arctic and conduct underwater sound propagation analysis. The ship covered 17,000 miles in 57 days and surfaced three times through the ice including a break-through at the Pole October 10th. *Pintado* also worked with Coast Guard icebreaker USS *Northwind* (WAGB-28) as well as ice stations Boxer, Arlis and Sylvia. The November 10, 1978 family newsletter of *Northwind* noted: "One of our new experiences was to witness a submarine sail appear through the ice and slowly grow as the deck of the *Pintado* pushed its way through the ice. We then used our helos to exchange movies and food with *Pintado*. The *Pintado* gave *Northwind* a beautifully decorated cake depicting the 22 October 1978 rendezvous and we gave *Pintado* fresh fruit." *Northwind*'s Commanding Officer lifted to *Pintado* by helo for a preoperational conference. Captain Garrett carried six covers, posted aboard *Northwind* on October 22, during the transfer listing details on reverse, and presented three to CO *Pintado*.

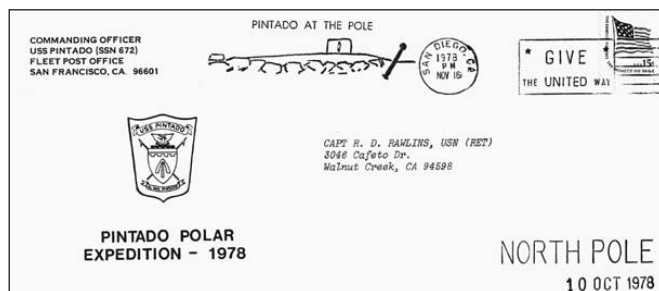


Figure 28. 1978 cover for *Pintado* Polar Operation. The submarine silhouette and two line rubber stamps were applied to crew and collector mail as operation documentation.

Collector mail received a two line and ship silhouette hand stamps noting the North Pole surfacing. *Pintado* also prepared about 1,500 covers for this expedition with a printed cachet, to which were added the pictorial hand stamp and two line North Pole-date stamp (figure 28). Covers were mailed at San Diego November 16th after the ship's return to her home port.

SublceX 1-79, USS *Archerfish* (SSN-678)

USS *Archerfish* (SSN-678) departed her home port of New London March 14, 1979 for Arctic waters to collect bathymetric and environmental information and maintain the capability and proficiency of operating a submarine in Arctic waters. The voyage was divided into three segments. Initially, the ship conducted a series of torpedo test firings along the edge of the ice field east of Greenland. Canadian helos, operating from Thule, provided logistic support. Phase two included that portion of the trip to and from the North Pole for which the ship had been assigned the most extensive scientific survey package planned to date. The ship was cruising under the ice pack on April 6th, the 70th anniversary of CDR Robert E. Peary's North Pole expedition, and surfaced at the North Pole on April 21st. During phase two, *Archerfish* traveled almost 10,000 miles under ice in 40 days. The final phase involved classified operations with the British Navy after which the ship visited Plymouth, England.

A cachet was planned for the operation and a contest was held to select the best design, won by Lt. (jg) K.W. Comer. A rubber stamp was manufactured at a small local shop by a sailor who moonlighted there in the evenings in order to preserve the classified nature of the operation. The rubber stamp cachet (fig-

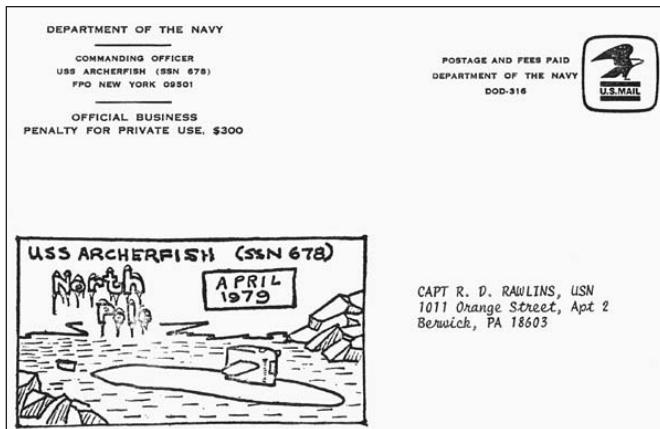


Figure 29. Following her 1979 Ice Exercise, *Archerfish* serviced about 600 monarch envelopes with a rubber stamp cachet and penalty indicia along with similarly cacheted crew and collector covers during a visit to Plymouth, England.

ure 29) was applied to approximately 600 monarch sized covers issued with printed corner card and penalty indicia. These covers and 200-300 cacheted personal and collector mail were posted May 14th at the U.S. Naval Facility in London (U.S. Navy FPO 09510).

Sublcex 1-81, USS Silversides (SSN-679)

USS *Silversides* departed her home port of Norfolk, Virginia on September 9, 1981, visited Halifax, Nova Scotia and then participated in a combined exercise involving submarines of the U.S. and British navies and USCGC *Northwind*. Following the exercise, *Silversides* continued operations under the ice cap for a total of 54 days, surfacing October 11th at the North Pole. Following the operation, the ship visited Haakonsværn, Norway, November 19-23, then Faslane, Scotland before returning to Norfolk on December 8th.

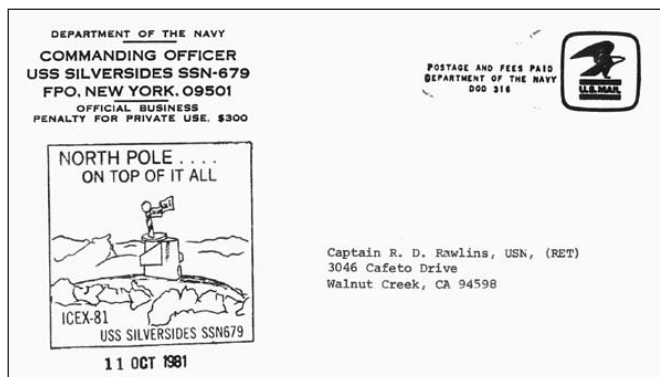


Figure 30. In 1971, *Silversides* attempted to mail her rubber stamp cacheted "official" covers in Norway and Great Britain as "Paquebot" mail. Unsuccessful, all polar voyage mail was finally posted in USS *Holland*, then stationed at Holy Loch, Scotland.

As had then become customary, a voyage cachet designed by crew members Machinist Mate Steven Weedling and Chief Hospitalman J.S. Bartholome was selected in a contest (figure 30). The rubber stamp was commercially made before the cruise.

Approximately 300 official mail covers with penalty marking were prepared with an enclosed letter of greeting from the North Pole. The ship attempted to mail these from

Haakonsværn as "Paquebot" mail, but the local Norwegian postal authorities were unfamiliar with the procedure. They offered to obtain permission from Oslo, but the Commanding Officer demurred due to lack of time. At Faslane, British postal authorities were cooperative, but could not guarantee prompt dispatch and the ship opted to mail the voyage covers from USS *Holland* at nearby Holy Loch, with a November 25 postmark. Up to 500 crew and collector cacheted covers were also mailed in USS *Holland*.

PacSublcex 1-82, USS Aspro (SSN-648) and USS Tautog (SSN-639)

Pearl Harbor based *Aspro* and *Tautog* departed port October 14 for a winter rendezvous at the North Pole on November 20, only the second time that two submarines had surfaced together at the North Pole. The ships spent about 20 hours surfaced, each hosted a dinner for the other Captain, conducted ceremonies and collected scientific data. The exercise enhanced the Navy's ability to operate and, if necessary, fight under the ice cap. The ships returned to Pearl Harbor December 15th after spending about 40 days under ice.

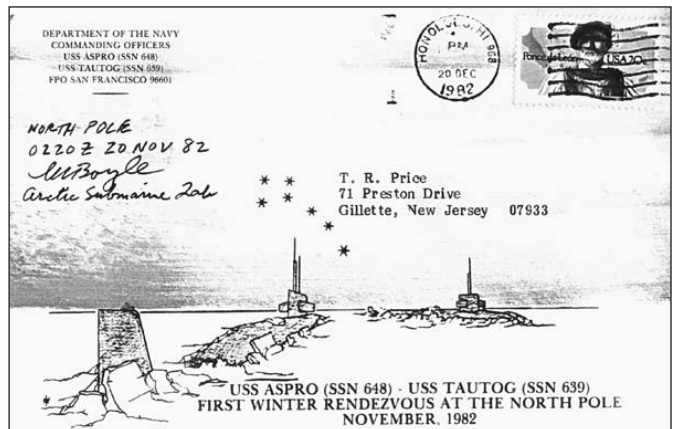


Figure 31. USS *Aspro* and *Tautog* issued a most attractive cover for a joint polar operation in 1982. The printed monarch cover, showing both submarines surfaced in the ice, was given a water color wash after the voyage by two crew members before mailing. The member reported his wife was not a very happy wife with covers drying on every available flat surface.

The commemorative covers for this voyage are unique (figure 31). Designed by Chief Quartermaster Russell B. Starr, the envelopes were tinted with a colour wash by Starr and Electronics Technician Randy Reynolds, both of *Aspro*, after returning to port. Eight acrylic colours were used to prepare the wash; as a result, the end product varied from a light to a deep blue. Approximately 2,500 envelopes were tinted and mailed at Honolulu December 20th. An enclosed letter sent greetings from both Commanding Officers.

Sublcex 1-83, USS Tautog (SSN-639)

USS *Tautog* returned to the Arctic the summer following joint operations with *Aspro* and surfaced at the North Pole August 5th, 25 years after USS *Nautilus* had achieved that objective.

Tautog issued a printed monarch sized cover which enclosed a letter of greeting from the Commanding Officer, dated August 5, 1983. The covers were mailed at Honolulu October 21, following ship's return to Pearl Harbor.

Subsequent Developments

The Navy has continued its polar explorations with annual submarine forays under the ice through the current time. Joint operations were mounted in 1984 by *Gurnard* and *Pintado*; in 1985 by *Aspro* and *Queenfish*; in 1986 by *Archerfish*, *Hawkbill* and ray; in 1987 by *Billfish*, *Seadevil* and HMS *Superb*; and in 1991 by *Pargo* and HMS *Tireless*. In 1988, *Queenfish* again retraced the route that USS *Nautilus* had taken in 1958.

In 1993, the Navy and the National Science Foundation struck an agreement for an annual scientific submarine polar cruise in which scientists from various colleges and laboratories would participate. To date, SubIceXes have been conducted by *Pargo* in 1993, *Cavalla* in 1994, *Sandlance* and *Pogy* in 1996 and by *Archerfish* in 1997 as she proceeded from her Groton, Connecticut home port via the North Pole to Puget Sound Naval Shipyard for decommissioning. The submarines have continued to document their operations with rubber stamp cachets designed for the operation and, in some cases, fancy postmarks although they are not authorized by the US Postal Service. Nonetheless, collectors are happy to receive such mail, whenever, wherever and however it can be obtained.

Acknowledgements

The author wishes to thank the officers and enlisted men of the submarines who provided information on the philatelic aspects of the submarine polar operations. Such information rarely appears in print and, without their input, those details would be lost.

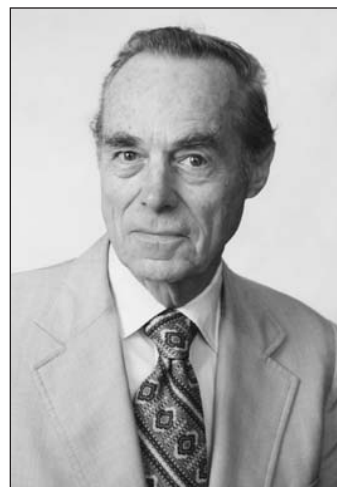

MORE ON JUDGING SHEETS

Dear Editor:

I have had a little bit of feedback about the article in *The Canadian Philatelist*. Those from the clubs listed have said thanks for the publicity. All have asked why the three draft judging pages were shown (p. 220-1). I said that the choice of what to publish was up to the editor. A common reply was, "Well, I hope he let's others know which one is correct."

I would appreciate a bit of clarification about the sheet.

(1) The current sheet most closely resembles the third of the three sheets shown, but it now has points added for just three award levels, at the suggestion of our American colleagues.

(2) The text quoted was from the "Extended Criteria." The judging sheets have a condensed set of criteria on the back of each.

(3) The French sheets were translated by a professional translator, then checked by both Grégoire Teyssier and

Charles Verge, as to the correct philatelic terms.

At Charles' local judging seminar in Brampton, ON on Sunday, October 3, there were 14 in attendance, including eight now in the RPSC judging program. A few in the group had some previous experience with the local sheet, while it was new to several others.

Charles stressed that the judges should have a knowledge of and use the listed local criteria, since local judging is different from National level judging, since presentation is an important criteria at the local level.

He stressed judging the material presented in the exhibit, and not what is "missing." He noted that scarcity, rarity and philatelic importance are not parts of the local criteria.

He stressed the importance of using a standard set of criteria to "level the playing field", and the need for positive written comments for each exhibitor.

After the presentation, three of the participants in the seminar expressed an interest in possibly joining the judging program as apprentices.

You might make a note that I'll be happy to send out copies of the sheets, either in English or French, upon receipt of a Self Addressed Stamped Envelope.

CRITERIA FOR EVALUATING EXHIBITS (IN LOCAL SHOWS)

TITLE PAGE	10 points
♦Title	The title should be brief, clear and inclusive. It should appear <i>only</i> on this page. (Also included here could be a second (<i>plan</i>) page for thematics.)
♦Scope (Introduction)	This should expand on the title and define the scope, or limits, of the exhibit.
♦Plan/Outline/Organization	One of these is needed to give the sequence and arrangement of the exhibit. It should indicate how the exhibitor will accomplish the stated purpose. (In a thematic exhibit, the inclusion of a plan is most desirable.)
<i>The title page is a guide which should educate the viewers, including the judges, giving them a very clear idea of what they will see in the exhibit, especially those who may not be familiar with the material.</i>	
DEVELOPMENT	15 points
♦Development	The exhibit should have a clear beginning, a central theme and a logical ending. The development should conform to the plan, outline or statement of organization. The exhibit should show continuity.
♦Coverage	The material selected should illustrate the chosen subject or theme. The exhibit should have balance and cohesion. Unrelated material should not be included.
KNOWLEDGE & RESEARCH	25 points
♦Knowledge	The degree of knowledge is expressed by the choice of a wide range of philatelic and/or thematic material. The write-up should be clear and concise, and correctly describe the material shown.
♦Personal Study (Research)	The write-up should go beyond information which is available in standard catalogues (<i>or reference works for thematics</i>). Key or special items should be appropriately discussed.
PHILATELIC MATERIAL	30 points
♦Selection	Material in the exhibit should be identified correctly and be appropriate to the topic. (The presence of unusual or interesting items should be given consideration.)
♦Challenge	Consideration is given to the degree of difficulty in assembling the material shown.
♦Condition	This is based on an assessment of the quality of the material shown relative to the condition in which such material is readily available.
PRESENTATION	20 points
♦Visual Appeal	The exhibit should be easy to understand and be attractive to viewers. Philatelic material should dominate the pages throughout. Page stock should be uniform, preferably of white or a light colour.
♦Write-up	The text should be easy to read and follow. It should be consistent in size and style. The text should not overwhelm the philatelic material.
♦Mounting	Mounts and framing of material should be neat, consistent and inconspicuous.
♦Layout	Pages should be neat, with tasteful balance of material. Pages should neither be too crowded nor too empty.

EXTENDED CRITERIA LIST

TITLE PAGE(10%): *The title page is a guide which should educate the viewers, including the judges, giving them a very clear idea of what they will see in the exhibit, especially those who may not be familiar with the material. (See Note 1, below.)* **TITLE:** The title should be brief, yet clear and inclusive. It should appear ONLY on this page. The title should be sufficiently larger than the text as to be obvious, but not so large or bold as to be overpowering. (Also included here could be a second-PLAN-page for thematics. The use of a separate plan page is encouraged for a highly developed thematic exhibit.) **INTRODUCTION:** This should expand on the title and define the scope, or limits, of the exhibit. (A one or two sentence summary should suffice, here.) **PLAN/OUTLINE/STATEMENT OF ORGANIZATION:** One of these is needed to give the sequence and arrangement of the exhibit. It should indicate how the exhibitor will accomplish the stated purpose. (This part should briefly list and/or explain the contents of the exhibit like a table of contents does in a book. It should tell "where to find what"-preferably identifying exhibit sections by frames, or by page numbers in a short-exhibit.)

Note 1: The title page should focus on the exhibit and the material it contains, NOT on the subject's historical background. However, in a Postal History exhibit, SOME historical information is usually needed on the title page.

DEVELOPMENT (15%): **DEVELOPMENT:** The exhibit should have a clear beginning (*the title page*), a central theme (*the bulk of the material*) and a logical ending (*without saying "The End"*). (The conclusion should refer back to your title page, "tying" the exhibit together.) The development should follow the plan/outline/statement of organization. The exhibit should show continuity. **COVERAGE:** The material selected should illustrate the chosen subject or theme. The exhibit should show balance between sections. The exhibit should show cohesion-*coverage should seem complete, within the stated limits*. Unrelated material should NOT be included. (All aspects identified in the introduction and/or plan, etc., should be present and shown in proportion to their significance.)

KNOWLEDGE & RESEARCH(25%): **KNOWLEDGE:** The degree of knowledge is expressed by the choice of a wide range of philatelic and/or thematic material. The write-up should be clear and concise, and correctly describe the material being shown. **PERSONAL STUDY (RESEARCH):** The write-up should go beyond information which is available in standard catalogues (or reference works for thematics). Key/special items should be appropriately discussed. (In a Postal History exhibit identification of markings by discreet reference to a standard text can be helpful.)

PHILATELIC MATERIAL (30%): **SELECTION:** Material in the exhibit should be identified correctly and be appropriate to the topic. (The presence of unusual or interesting items should be given consideration.) (See Note 2, below.) (Judges dislike mixed mint and used items together in the same series-SHOW THEM SEPARATELY.) **COLLECTING CHALLENGE:** Consideration is given to the degree of difficulty normally expected in assembling the material shown. **CONDITION:** This is based on an assessment of the quality of the material shown relative to the condition in which such material is readily available.

Note 2: THEMATIC EXHIBITS will be improved by a variety of philatelic items (*spread across the exhibit*) besides regular stamps, souvenir sheets and uses on commercial covers. These might include such items as coils, booklets, different types of stamps, varieties, meters, special cancellations, postal stationery, (A) maximum card, etc.,-IF THEY RELATE TO THE CHOSEN THEME.

PRESENTATION (20%) (See Note 3, below): **VISUAL APPEAL:** The exhibit should be easy to understand and be attractive to viewers. Philatelic material should dominate the pages throughout. There should be SOME variety in page arrangements, especially between consecutive pages. Page stock should be uniform, preferably of a white or light colour. **WRITE-UP:** The text should be easy to read and follow. It should be consistent in size and style. The text should not overwhelm the philatelic material. **MOUNTING:** Mounts and framing of material should be neat and inconspicuous. (If a colour photocopy or computer scan of one complete side of a cover is used it should NOT be life size-70% is suggested.) (Any highlighting of "key" items should be done subtly.) **LAYOUT:** Pages should be neat, with tasteful balance of material. Pages should neither be too empty nor too crowded.

Note 3: In local level shows PRESENTATION is a major factor in determining awards. As the exhibit moves up in levels, through Regional and National, then to International, Presentation becomes of decreasing importance (from 20% down to 5%); while Rarity, Scarcity and the overall Philatelic Importance of the exhibit become increasingly important. AT THE LOCAL LEVEL, RARITY, SCARCITY AND PHILATELIC IMPORTANCE ARE NOT PARTS OF THE JUDGING CRITERIA.

NOTE 4: JUDGES WILL BE MADE AWARE OF EXHIBITS BY NOVICE AND/OR YOUTH EXHIBITORS.

Cette partie doit indiquer comment l'exposant parvient au but qu'il s'est fixé. 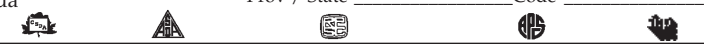

Phillips' British Commonwealth Stamps and Covers Sale held on September 23, 1999 contained many wonderful items to tempt collectors.

The Canadian section included a full Mint 1/2¢ - \$5 set of the 1897 Diamond Jubilee issue, estimated at £700-900 (lot 237). Although some of the stamps had small faults, the set still sold for a respectable £920 (C\$2,257.40; prices include the 15 per cent buyer's fee).

Lot 258 contained a large collection of booklets, coils, dies, varieties, papers etc. of the 1967-73 Centennial issue. Estimated at £500-600, it sold for £632.50 (C\$1,551.97).

Commonwealth material was especially strong with many lots attracting collectors' attention.

Falkland Islands was popular and lot 317, containing a nicely-centered Mint copy of the 1933 £1 Black and Carmine King George V value, sold for £598 (C\$1,467.31) against an estimate of £360-400. A Fine Used copy of the same stamp (lot 318) was estimated at £500-600 and went to a new owner for £747.50 (C\$1,834.14).

Hong Kong was represented in 12 lots and among those were several larger collections

A Mint and Used collection of 210 stamps from the King George VI-era (lot 365), containing many key issues from

1938-52, realized £805 (C\$1,975.23) against a £700-800 estimate.

A Queen Victoria Mint and Used collection in mixed condition on stockleaves (171 items), was estimated at £360-400 and reached an incredible £1,265 (C\$3,103.93; lot 366).

Lot 463 featured a scarce Mint copy (although creased and stained) of the 1914-15 "G.R.I./5s." overprint on the 5m. Carmine and Black Hohenzollern Yacht from New Guinea (New Britain). Estimated at £2,000-2,500, the stamp sold for £2300 (C\$5,643.51).

Many collectors of New Zealand would have found lot 494 of interest. It contained a large collection of Queen Victoria to Queen Elizabeth mainly Used items including Chalon heads (and a 2d black Proof), side portraits and pictorials to five values, back of the book postage dues and fiscals, and many FDCs and covers. The lot was estimated at £400-500 and it sold for £828 (C\$2,031.66).

The fourth edition was published in October 1999. It contains a list of all publications currently available, including many scarce volumes – some of which are out of print.

Many of the books written years ago have not been replaced by more current research.

Although many of the listings are about specialized classical subjects, there are a number of books available on the more modern issues.

Some of the listings include book reviews reprinted (with permission) from other journals.

The publisher has also marked some of the books as being key sources for information.

Normally, we do not review catalogues, but this is one of the exceptions which proves the rule. It is mentioned because many members live outside of Canada and would not normally have knowledge about this compendium of information.

This catalogue #210 is an invaluable reference source for any serious collector of Canadian stamps.

The catalogue will save a collector much time and anxiety when looking for specific information about a particular subject.

How much should I pay for a stamp for my collection? An often asked question. There is no simple answer to this. Then you look at a dealer's stock or an auction catalogue or any price list you will see that prices for a single stamp may vary considerably. Why? The other question one may ask is do I really want to buy this stamp and why?

Is it just because I want to fill a space in my album or is it because I like to be updated with all issues or maybe I could get along without the stamp. The need to buy a stamp must be weighed carefully against these questions. That is especially true if the stamp is expensive or sold out and can only be obtained from a dealer. This has happened lately with some recent commemoratives that hit the sky in price after they were sold out by the PO. You may think that if you do not have every stamp in your collection, the collection is worthless. This is not true at all. This is the nice part of collecting. You can choose what you like to have and no one else has to be involved in this decision. The collection should be

representing a unit, that is a show of commemoratives, or definitives only, or only blue stamps etc. One German collector collects only all blue issued definitives and nothing else. He does not have to spend much on other stamps that do not fit his collection.

Shall I pay the price the catalogue lists or the estimate an auction puts on a lot? And how come the estimate is about double that of the regular list price? Listed prices in catalogue or estimates in auctions are simply guides not final prices.

Remember this. One factor plays a major part. That is the condition of the stamp. Many catalogues show what they mean by condition. Make sure you read this, as each may have different ratings. You may find a stamp listed at \$10 and the same one at \$30. It is obvious that the \$10 stamp is not in perfect condition, but that is all you like to spend. Then remember that stamp will always be a second class one, even in 20 years and unlikely go up in price with time. There is a limit of what one should pay but a

Very Fine condition stamp will always be a pleasure for you or anyone else to look at. Recent auctions have shown that Very Fine condition stamps bring very good prices for above the catalogue value. This is true for all stamps especially for older issues. The question of whether a stamp must be unhinged or not can only be answered by you. For any exhibit purposes, the back does not show and is not as important as the front. So do not waste your money on unhinged stamps in that case. For any new collector, always make sure you buy the best and you will never be sorry.

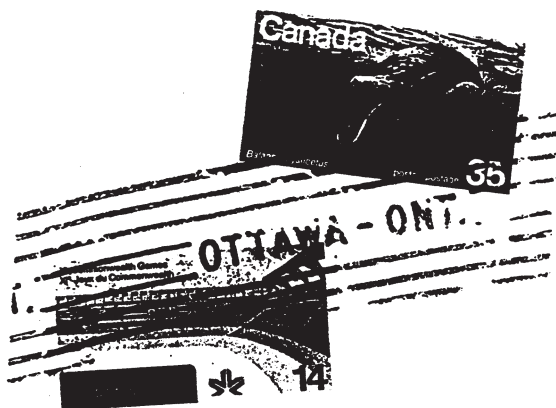
Just a few examples of odd cancels indicate the range of them. There must be some collectors gathering these cancels. Many cancels have seen only a short period of usage. It would be interesting to have collectors watch out for them and report them to this magazine. Many years ago *Popular Stamps* was a magazine that used to report any such new cancels but that publication is gone a long time.

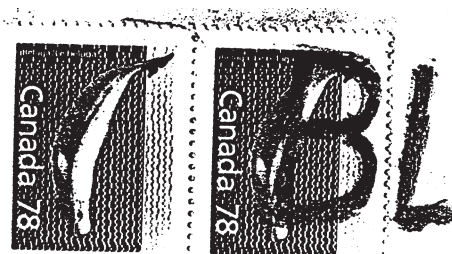

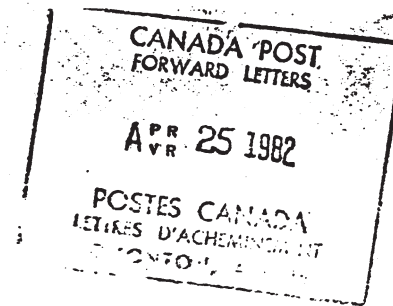

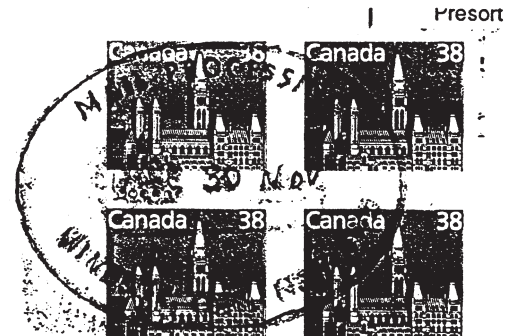

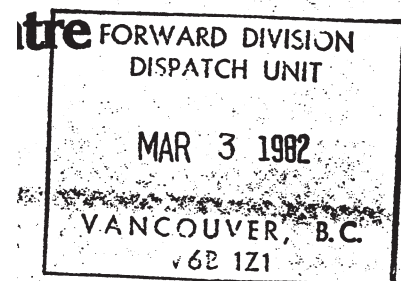

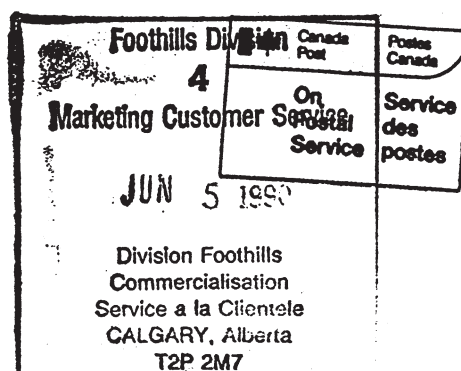

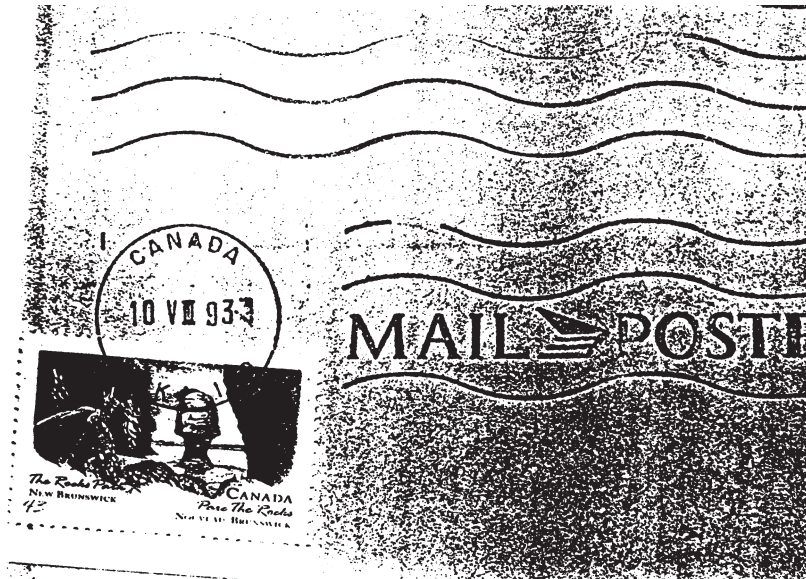
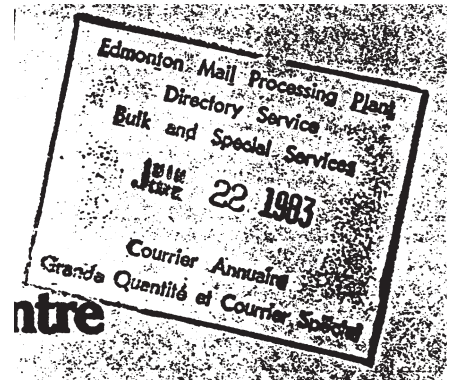

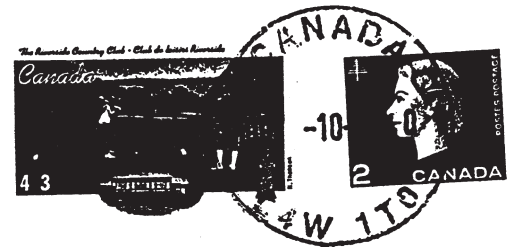

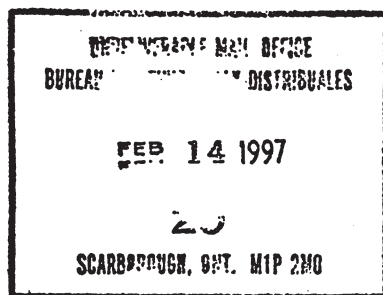

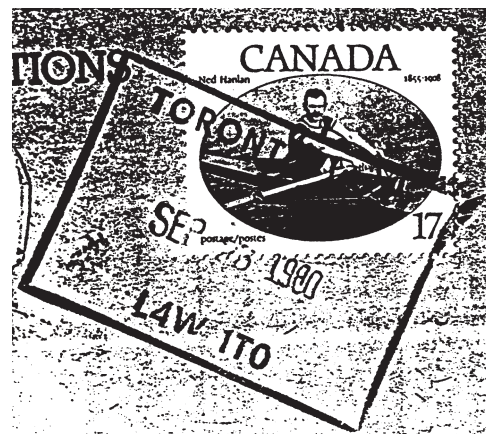

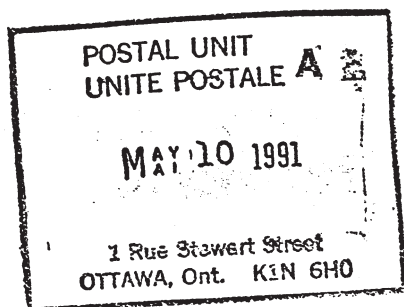

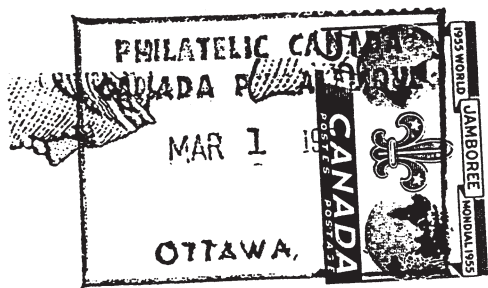

There are others that did not reproduce well, but the above just indicates what can be found in the mails.

So, what do you think will happen this Millennium to stamps? I am sure you are aware of the enormous pressure the PO is under to cope with the increasing use of email, fax etc. In modern times snail mail does not make much sense anymore. You will have experienced receiving letter mailed 50 minutes flight away from your place, arriving after two weeks or waiting for a letter that never arrives and is lost. Is this automation? But on the other hand with reduced mailings, the PO brings out more and more stamps. Some special with small printings. Why when most of them will never be used in any quantities and end up later on as 10 to 20 per cent less face value for postage? Is this peculiar to Canada? No, other countries have the same problem and are trying to do something about it. In one large city in Europe the PO is not staffed at all and only machines are there to help you transmit your mail. You note I say transmit not mail. These machines can fax, e-mail and charge you by credit card or bill the amount you owe to the PO. The machines weigh, correct postage, mark for transmit action and sort. No stamps are used but various marks or labels. Once you put your paper, envelope or card into a slot, the rest is automatically read and acted upon.

Can we expect that stamps will soon be passé? Likely, but as long as ardent collectors sit on the stamp advisory board you will get your stamps even if you cannot use them. The cost of producing stamps is increasing. This is evident from the additional surcharges our PO charge for any special such as souvenir sheets, commemorative postal stationery and other gimmicks. Even Scott will not list all these specials anymore. For large mailings, envelopes are precoded and that makes sense. For ease of handling, Sweden has made use of coil stamps for almost a century. The actual tag-

ging of mail or stamps has been tried for many years now but has not resulted in faster mail. Multiple tagging and coding can often be seen on mail indicating that a letter may have gone through at least two or three systems before delivery. The unique e-mail code could be an answer not everyone has a computer. There would be no need for tagging or other coding that is often confusing. The only reason why special Christmas envelopes did not work, is that the manufacturer of Christmas cards objected to this PO idea and was losing sales.

The various Express envelopes that are marketed may speed up some delivery similar to the Special Delivery that once existed. Even so, one such envelope mailed in August to New York arrived finally after 12 days. Another annoying thing is that any registered letter must go through a custom clearance process. Many recipients are charged with GST when the items come from outside the country. So, especially collectors, are advising companies either not to mail by registered or not to include an invoice. Others not too far away from the U.S. border, simply have a box across in a U.S. PO and pick the mail up there. A trip often takes less than one hour.

So in brief, yes stamps will continue for a while but the speeding up of mail systems will inevitably come soon. ♣

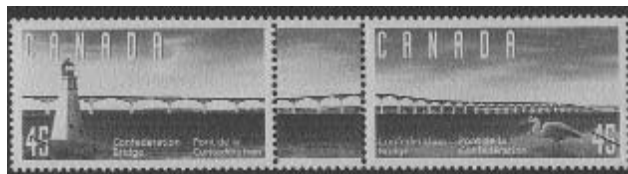

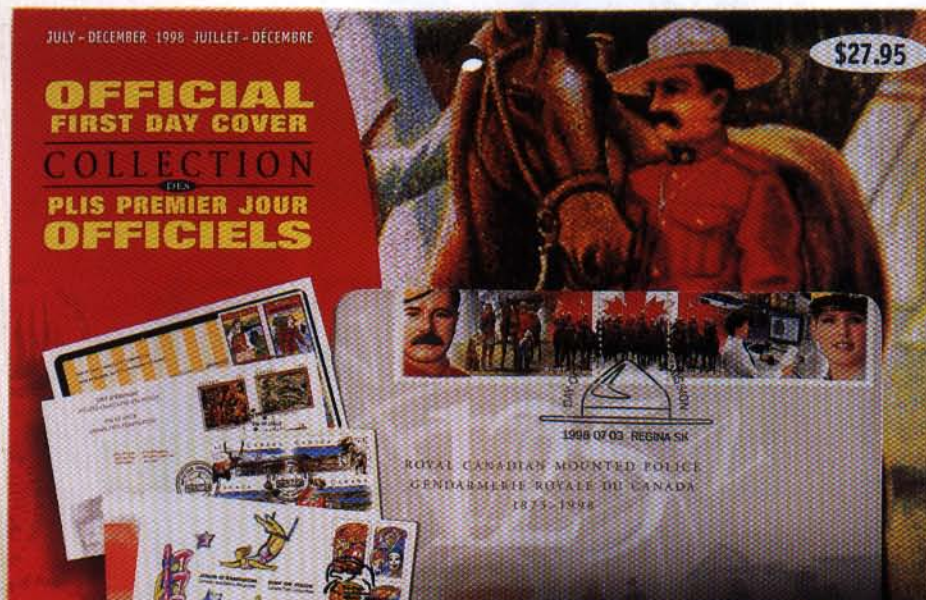

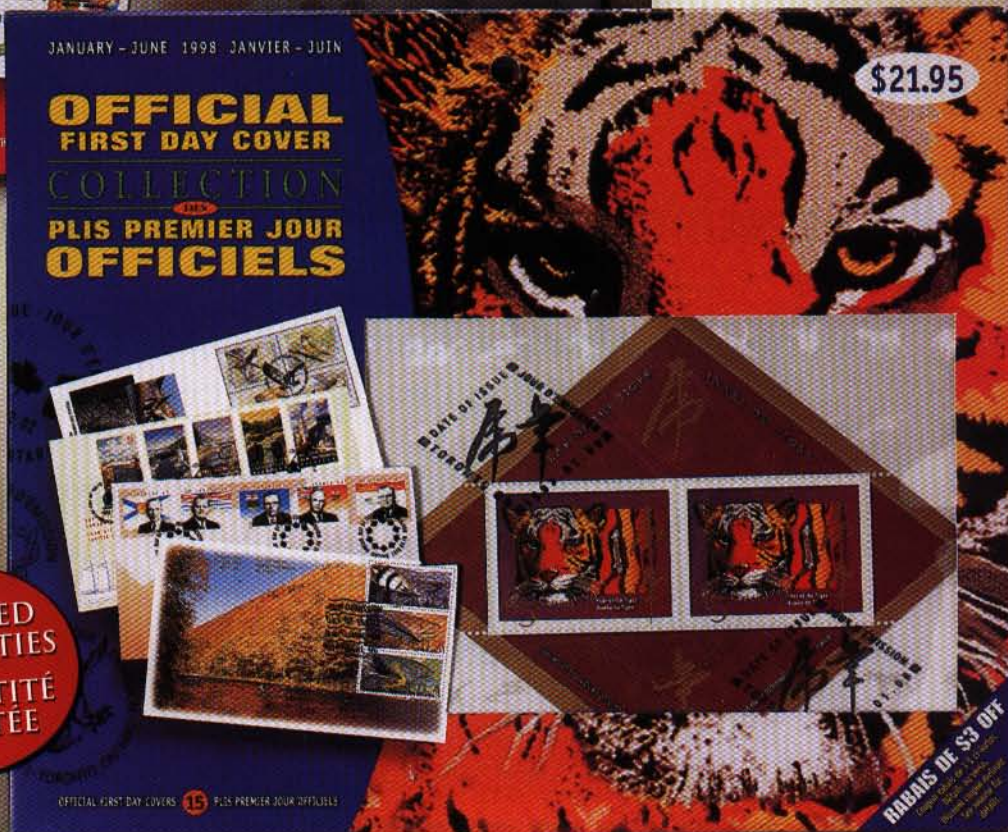
